NRVHSCD's vision is that all patients in Romania who need a hematopoietic stem cells transplant from an unrelated person, to have this intervention in one of the transplant centers in the country.

MISSION

NRVHSCD's mission is to identify and provide, at international standards, voluntary compatible unrelated donors of hematopoietic stem cells, to all patients in Romania who need a hematopoietic stem cells transplant and for whom related compatible voluntary donors do not exist.

GENERAL OBJECTIVES FOR 2012

1. Amending national legislation in this field, in accordance with the requirements of European and international law

- 1.1. Proposal to amend Law no. 95/2006 on healthcare reform
- 1.2. Proposal to amend and supplement GD no. 760/2009 on the establishment of the National Register of Voluntary Hematopoietic Stem Cells Donors, and for approving the establishment of an activity financed entirely from own revenues
- 1.3. Proposal for a GD regarding the approval of the fees and taxes paid by the National Register of Voluntary Hematopoietic Stem Cells Donors for interconnection with international structures, for the year 2012
- 1.4. Proposal to supplement the Order of the Minister of Health No. 474 of 2011 regarding the composition of the Scientific Council of the Register
- 1.5. Proposal for an Order of the Minister of Health regarding the approval of the eligibility criteria to be met by the health units that carry out activities of recruitment, testing and donation of hematopoietic stem cells from unrelated donors
- 1.6. Proposal for an Order of the Minister of Health regarding the designation of health units carrying out recruitment, testing and donation activities
- 1.7. Proposal for an order of the Minister of Health regarding the National Standards of the Register
- 1.8. Proposal for an order of the Minister of Health regarding Standard operating protocols and forms
- 1.9. Proposal for an order of the Minister of Health regarding Stem cells donation procedure

2. NRVHSCD to become functional by meeting the conditions required by European and international standards in the field (standards of the World Marrow Donor Association - WMDA)

- 2.1. NRVHSCD recertification for quality standards: ISO/IEC 9001:2008 - quality management system and for ISO/IEC 27001: 2005 - information security management system
- 2.2. Defining and implementing standards of organization and operation
- 2.3. Defining and implementing standards for traceability
- 2.4. Defining and implementing standards for the professional training of the personnel involved.

2.5. Defining and implementing communication standards

3. Creation of the computer database on the Romanian territory regarding the individuals who have given their consent to donate stem cells, in which to be provided the personal, medical and histocompatibility data;

3.1. Validation as a donor of HSC of persons who have agreed to donate HSC voluntarily

3.2. Coordination of testing of voluntary hematopoietic stem cells donors

3.3. Registration of recruited and tested donors in the database

4. Implementing the interconnection of the National Register of Voluntary Hematopoietic Stem Cells Donors with similar international organizations.

4.1. Establishing partnerships with similar international organizations

4.2. Registration of NRVHSCD as a member of the following international organizations: WMDA, Europdonor - Bone Marrow Donors Worldwide (BMDW), European Group for Blood and Marrow Transplantation (EGBMT) and EMDIS;

5. Search and identification of compatible hematopoietic stem cells donors in its own database and in international databases, for Romanian patients, in order to perform in the country at least one bone marrow transplant from unrelated donors.

6. Search and identification of compatible hematopoietic stem cells donors in its own database, for foreign patients.

7. Implementation of the unique coding and labeling system, in accordance with the European coding requirements in the donation activity for the transplantation of hematopoietic stem cells from unrelated donors.

7.1. Registration of designated units in the International Coding Register ISBT128

7.2. Development and implementation of a computer application that allows coding and labeling in the ISBT 128 system

7.3. Training of NRVHSCD personnel and designated persons from health units designated for recruitment, testing and donation activities coordinated by NRVHSCD

8. Elaboration and implementation of information documents for hematopoietic stem cells donors

8.1. Development of an information package for hematopoietic stem cells donors

8.2. Development and maintenance of an information site for information and communication in the field of hematopoietic stem cells donation
